The Registrant agrees to be liable for all actions and omissions of the Bidder including in respect of any decisions by the Bidder during or after the auction of Block 7 Section 19 Wright, any subsequent execution and exchange of a Contract for Sale for Block 7 Section 19 Wright by the Bidder and to indemnify SLA in relation to any loss or damage as a result of the actions and omissions of the Bidder.

 - (a) warrant the information provided in this Form is accurate and complete in every respect;
 - (b) undertake to notify SLA if any of the information provided in this Form changes;
 - (c) release SLA in respect of any claim, cost, expense, loss, or other liability arising from the Registrant's appointment of the Bidder; and
 - (d) indemnify and will keep SLA indemnified against any claim, cost, expense, loss, or other liability arising from the Registrant's appointment of the Bidder.
