Terms and Conditions:

Eligibility & Entry

1. Entry is open to community members participating in the Birds Eye View Self-guided activity. Entrants must be over the age of 16 years.
2. Employees and immediate family members of the Suburban Land Agency (SLA) are ineligible to enter.
3. To enter, entrants must photograph a view including one (or more) of the bird sculptures located around Whitlam as part of the Birds Eye View activation, and then email their photographs to SLA.
4. Entries will be accepted via email only. Email to mingle@act.gov.au.
5. Entrants may enter as many photos as they wish, increasing their chances of winning.
6. Entry into the competition is free.
7. Photos must be taken by the entrant (or accompanying minor). Photos may be edited and/or digitally enhanced.
8. Entries must be submitted between 9am, 9 November 2024 and 11:59pm 7 December 2024.
9. By entering, participants grant SLA the right to use their photos for promotional purposes, sharing via our website, newsletter or social accounts.
10. SLA will not be liable for any loss, damage or injury suffered or sustained as a result of an eligible entrant entering into the Competition or accepting and/or using a prize in relation to the Competition, except for any liability which cannot be excluded by law.

Prizes & Selection

12. Judging criteria: Photos will be judged by a panel of judges from the SLA. All entries will be judged individually on creativity and originality, based on the following criteria: creativity (5 points), photographic skill (5 points), humour (5 points).
13. This is a game of skill and judges' decision is final, no correspondence will be entered into regarding the judging of the entries.
14. Two winners will be selected. First prize and a runner up prize. First prize will received a \$50 VISA gift card and Runners-up, a \$20 voucher for Heartbeat Café
15. Prizes must be picked up directly from the SLA office in Whitlam at 3 Klaus Moje Street, Whitlam ACT.
16. If for any reason, this promotion is not capable of running as planned, SLA may cancel, terminate, modify or suspend the promotion.
17. Winners will be selected on 11 December 2024, at the Whitlam Display Village. Winners will be notified on or before Friday 13 December 2024. The winner will be notified by email. The recipient will have 7 days to respond, after which time, if there is no response, the prize will be redrawn.
