Terms of Appointment

1. The Buyer hereby appoints the Agent to act on behalf of the Buyer for the following purposes:
 - (a) to attend to the Buyer's Block Purchasing Appointment on the Buyer's behalf;
 - (b) at the Block Purchasing Appointment, to select an available Block to purchase from SLA; and
 - (c) to pay the Deposit payable by the Buyer under the First Grant Contract on behalf of the Buyer.
2. The Buyer acknowledges and agrees that:
 - (a) payment of the Deposit by the Agent; and
 - (b) any Block selection made by the Agent,
 will result in a First Grant Contract being issued to the Buyer's solicitor for exchange within 10 working days of the date of the Block Purchasing Appointment.
3. By the Agent's execution of this Form, the Agent accepts the appointment as agent for the Buyer.
4. The Buyer and the Agent:
 - (a) warrant the information provided in this Form is accurate and complete in every respect;
 - (b) undertake to notify SLA if any of the information provided in this Form changes;
 - (c) release SLA in respect of any claim, cost, expense, loss, or other liability arising from the Buyer's appointment of the Agent; and
 - (d) indemnify and will keep SLA indemnified against any claim, cost, expense, loss, or other liability arising from the Buyer's appointment of the Agent.
