## 1. Background

- 1.1 The Board of the Suburban Land Agency (**Agency**) has established a People and Transition (Committee) in accordance with the *City Renewal Authority and Suburban Land Agency Act 2017*.
- 1.2 This charter sets out the Committee's role, responsibilities, authority and operation.

## 2. Purpose

### *Role of the Committee*

- 2.1 The Committee assists the Board to fulfil its oversight responsibilities in relation to significant human resource issues.

## 3. Authority of the Committee

- 3.1 The Committee is accountable to and acts as an advisory body to the Board. The Committee has such authority as is delegated to it from time to time by the Board, in accordance with the *City Renewal Authority and Suburban Land Agency Act 2017*.

### *Access to management and information*

- 3.2 The Committee will have access to senior management and full access to books, records and facilities of SLA, as required to carry out its role (subject to relevant legislation).

## 4. Committee Membership

- 4.1 Unless determined otherwise by the Board, the Committee will have a minimum of two members, including the Committee Chair.
- 4.2 All Committee members must be independent non-executive members of the Suburban Land Agency Board. The Committee Chair and members will be appointed by the Board. If a member of the Board is a member of the Committee and he/she ceases to be a member of the Board, he/she shall immediately cease to also be a member of the Committee.
- 4.3 Notwithstanding clause 4.2 above, the Suburban Land Agency Chief Executive Officer will be appointed to the Committee as an ex-officio member.
- 4.4 The Environment, Planning, Sustainable Development Director, People and Capability will receive a standing invitation to attend meetings in an advisory capacity.
- 4.5 Other members of management may be invited as requested by or agreed with the Committee Chair and the CEO.
- 4.6 Members of management must not be present during discussions or decisions in relation to their own remuneration, where this is the responsibility of the Agency to determine.
- 4.7 In exercising the functions of a Committee member, a member must exercise the degree of honesty, care and diligence and must:
  - a) act in good faith,
  - b) not pursue personal interests at the expense of the Suburban Land Agency's interests,
  - c) not to use Committee membership, including confidential information, to gain personal advantage,

- d) to adhere to the public sector values, principles and conduct requirements as set out in the Public Sector Management Act 1994,
- e) not to cause detriment to the Suburban Land Agency or undermine its reputation, and
- f) to comply with any other code of conduct including any other applicable policies adopted by the Board from time to time.

## 5. Objectives

- 5.1 The Committee is directly responsible and accountable to the Suburban Land Agency Board for meeting its objectives. In carrying out its responsibilities, the Committee must at all times recognise that primary responsibility for management of the Suburban Land Agency rests with the Suburban Land Agency Board and the Chief Executive Officer in accordance with the *Financial Management Act 1996* and Human Resource delegations sit with the Chief Executive Officer.
- 5.2 The objectives of the Committee may be revised or expanded in consultation with, or as requested by, the Suburban Land Agency Board from time to time.

### **Responsibilities**

- 5.3 The People and Transition Committee responsibilities are to advise the Board on its oversight of:
  - g) Organisational capability and resources;
  - h) Organisational culture;
  - i) Wellbeing of staff;
  - j) The management of significant human resources risks;
  - k) Diversity and inclusion, including the policy, strategies, measurable objectives, progress and disclosures;
  - l) The performance management framework;
  - m) The training, leadership and development framework, including the development of key capabilities;
  - n) Significant human resources policies that are specific to the Suburban Land Agency; and
  - o) Any other matters requested from time to time by the Board.
- 5.4 The Committee will advise the Chair of the Board on the setting performance indicators and reviewing the progress of performance, the annual review of the Chief Executive Officer against the performance indicators, and succession planning for the Chief Executive Officer.
- 5.5 The Committee will review a summary of the performance evaluation results of the Agency's employees.

### **External advice**

- 5.6 The Committee may request independent professional advice and/or services in relation to its responsibilities.
- 5.7 The CEO has the appropriate delegation to employ staff and engage consultants and contractors in accordance with the *Financial Management Act 1996* and the *City Renewal Authority and Suburban Land Agency Act 2017*.

## 6. Responsibilities of Committee Members

- 6.1 Members of the Committee are expected to understand and observe relevant legislative requirements including; the *City Renewal Authority and Suburban Land Agency Act 2017*,

the *Public Sector Management Act 1994 (including the operation of the Administrative Arrangements 2016)* and the *Financial Management Act 1996*.

- 6.2 Members must apply good analytical skills, objectivity and good judgment.
- 6.3 Members should express opinions frankly, ask questions that go to the fundamental core of the issue, and pursue independent lines of enquiry.

## 7. Reporting

- 7.1 At the next Board meeting following each Committee meeting, the Chair of the Committee will provide a written or verbal report to the Board in respect of the considerations, operations and activities of the Committee at its last meeting.
- 7.2 The Secretariat of the Committee will provide a copy of the minutes (or draft Minutes) of each Committee meeting to the Suburban Land Agency Board and all attendees as appropriate at the next available Suburban Land Agency Board meeting.

## 8. Meetings and Quorum

- 8.1 The Committee will meet at least four times per year.
- 8.2 A quorum will consist of **two** Committee members.
- 8.3 A meeting may be held using a method of communication, or a combination of methods of communication that allows a committee member taking part to hear what each other member taking part says without the members being in each other's presence. (*FMA Act S 97*)
- 8.4 A resolution is a valid resolution of the Committee, even if it is not passed at a meeting of the Committee, if all members agree to the proposed resolution in writing or by electronic communication. <sup>1</sup>(i.e. *circulating resolutions*).

## 9. Secretariat

### ***Committee Secretary***

- 9.1 The Chief Executive Officer will nominate a Suburban Land Agency staff member to provide secretariat support to the Committee.
- 9.2 In carrying out its function, the Secretariat will have regard to the process and procedures as set out in the Agency's Corporate Governance Framework as approved by the Board and amended from time to time.

### ***Reporting***

- 9.3 The Committee will operate in the following manner:
  - a) The Secretariat will liaise with the Chief Executive Officer and Chair of the Committee on the agenda prior to each meeting;

- b) The Secretariat will circulate papers to Committee members on a timely basis before the meeting, (at least 1 week prior or preferably a minimum of 5 working days prior to meetings);
- c) A copy of the minutes of Committee meetings will be provided to the Board at the next available Suburban Land Agency Board meeting;
- d) Draft minutes must be approved by the Chair and circulated within two weeks of the meeting to each member and Committee observers, as appropriate.

## 10. Conflicts of Interest

- 10.1 Committee members and any attendees to each Committee meeting must declare any conflicts of interest at the start of each meeting or before discussion of the relevant agenda item or topic.
- 10.2 Details of any declared conflicts of interest are to be recorded in the Committee meeting minutes.
- 10.3 Where members or attendees at the Committee meetings are deemed to have a real or perceived conflict of interest it may be appropriate that they are excused from Committee deliberations on the issue where a conflict of interest exists, at the Committee's discretion.

## 11. Assessment Arrangements

- 11.1 The Chair of the Committee, in consultation with the Chair of the Suburban Land Agency Board, will agree a review of the performance of the Committee at least every year.
- 11.2 The Committee shall perform a self evaluation of its performance at least every two years bi-annually to determine if it is functioning effectively.
- 11.3 The Board will evaluate the performance of the Committee as appropriate.

## 12. Review of Charter

- 12.1 The Committee will review this Charter annually and make recommendations to the Suburban Land Agency Board regarding proposed revisions.
